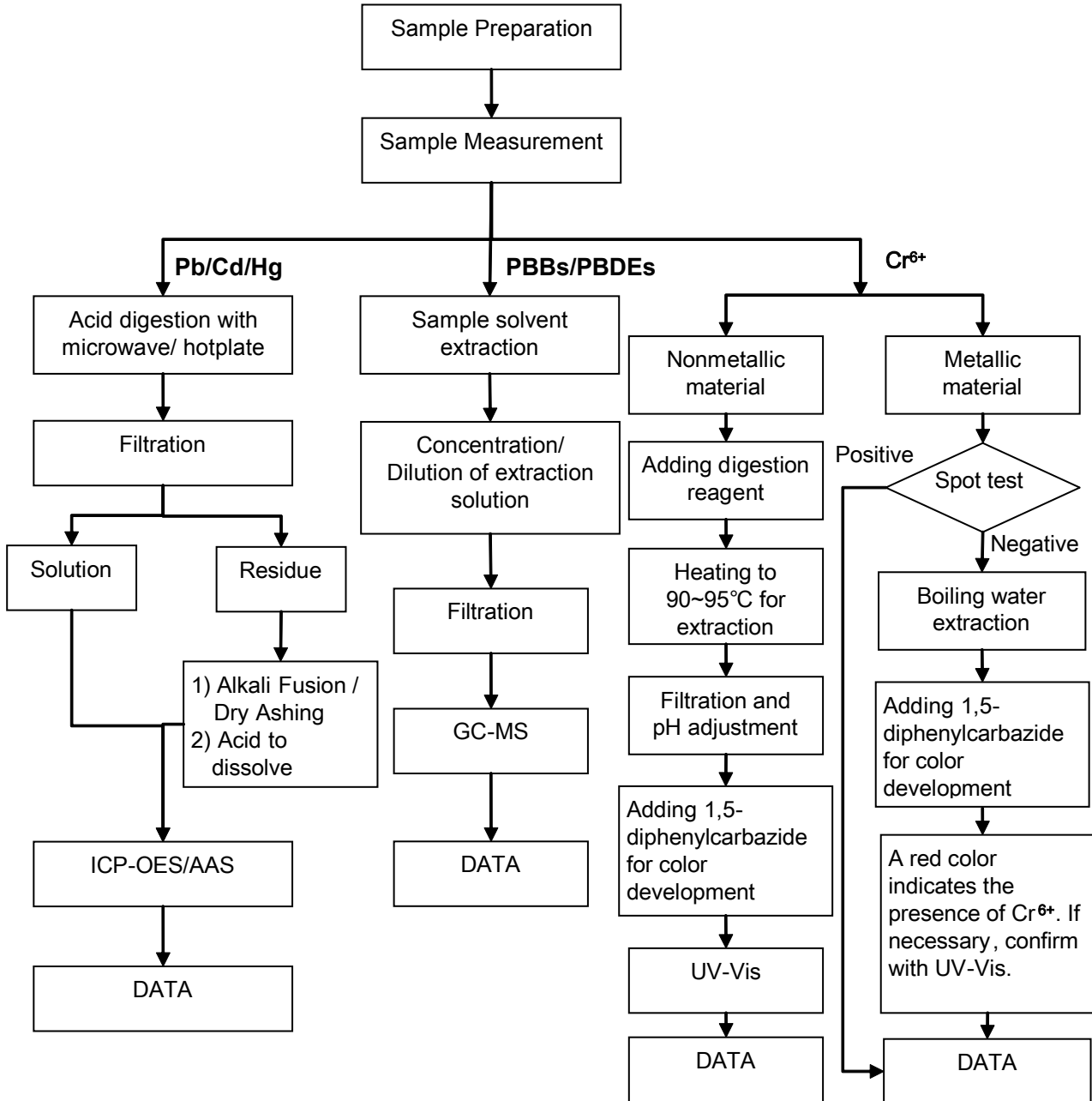

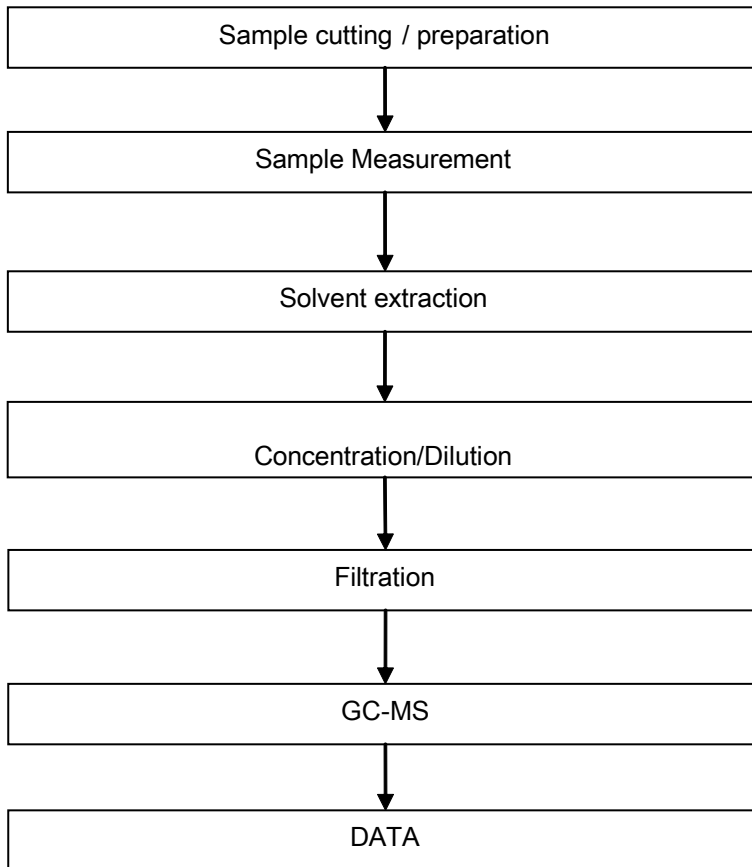

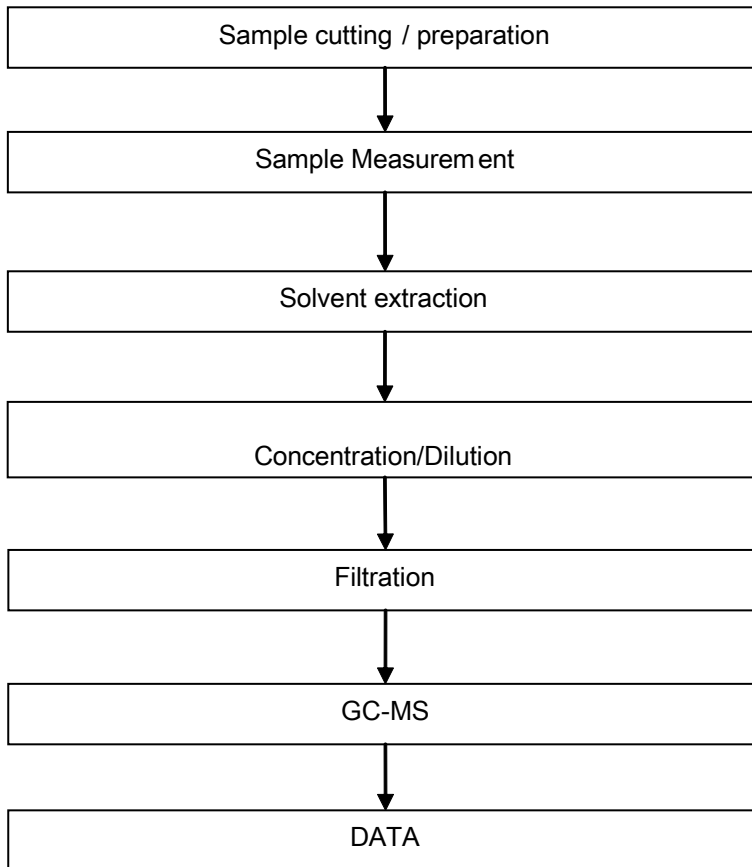

Phthalates Testing Flow Chart

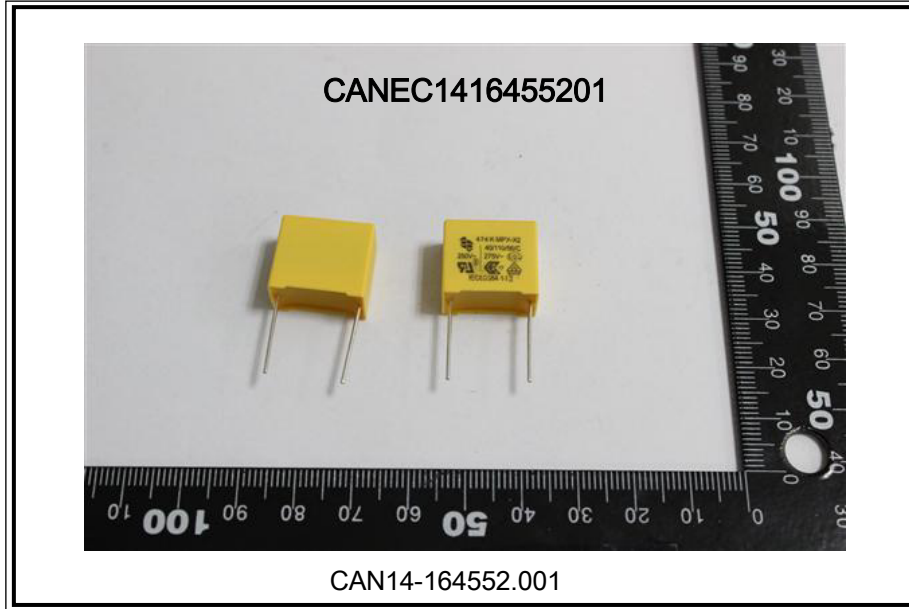
